**A BILL**

To amend the National Voter Registration Act of 1993 to require each State to implement a process under which individuals who are 16 years of age may apply to register to vote in elections for Federal office in the State, to direct the Election Assistance Commission to make grants to States to increase the involvement of minors in public election activities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Pre-Registration Of  
3 Voters Everywhere Act” or the “PROVE Act”.

4 **SEC. 2. PRE-REGISTRATION OF MINORS FOR VOTING IN**  
5 **FEDERAL ELECTIONS.**

6 (a) **REQUIRING IMPLEMENTATION OF PROCESS.—**  
7 The National Voter Registration Act of 1993 (52 U.S.C.  
8 20501 et seq.) is amended by inserting after section 8 the  
9 following new section:

10 **“SEC. 8A. PRE-REGISTRATION PROCESS FOR MINORS.**

11 “(a) **REQUIRING IMPLEMENTATION OF PRE-REG-**  
12 **ISTRATION PROCESS.—**Each State shall implement a  
13 process under which—

14 “(1) an individual who is a resident of the State  
15 may apply to register to vote in elections for Federal  
16 office in the State at any time after the individual  
17 turns 16 years of age; and

18 “(2) if the individual is not 18 years of age or  
19 older at the time the individual applies under para-  
20 graph (1) but would be eligible to vote in such elec-  
21 tions if the individual were 18 years of age, the  
22 State shall ensure that the individual is registered to  
23 vote in elections for Federal office in the State that  
24 are held on or after the date on which the individual  
25 turns 18 years of age.

1       “(b) PERMITTING AVAILABILITY OF PROCESS FOR  
2 YOUNGER INDIVIDUALS.—A State may, at its option,  
3 make the process implemented under subsection (a) avail-  
4 able to individuals who are younger than 16 years of  
5 age.”.

6       (b) EFFECTIVE DATE.—The amendment made by  
7 subsection (a) shall take effect upon the expiration of the  
8 90-day period that begins on the date of the enactment  
9 of this Act.

10 **SEC. 3. GRANTS TO STATES FOR ACTIVITIES TO ENCOUR-**  
11 **AGE INVOLVEMENT OF MINORS IN ELECTION**  
12 **ACTIVITIES.**

13       (a) GRANTS.—

14           (1) IN GENERAL.—The Election Assistance  
15 Commission (hereafter in this section referred to as  
16 the “Commission”) shall make grants to eligible  
17 States to enable such States to carry out a plan to  
18 increase the involvement of individuals under 18  
19 years of age in public election activities in the State.

20           (2) CONTENTS OF PLANS.—A State’s plan  
21 under this subsection shall include—

22                   (A) methods to promote the use of the pre-  
23 registration process implemented under section  
24 8A of the National Voter Registration Act of  
25 1993 (as added by section 2(a));

1 (B) modifications to the curriculum of sec-  
2 ondary schools in the State to promote civic en-  
3 gagement; and

4 (C) such other activities to encourage the  
5 involvement of young people in the electoral  
6 process as the State considers appropriate.

7 (b) ELIGIBILITY.—A State is eligible to receive a  
8 grant under this section if the State submits to the Com-  
9 mission, at such time and in such form as the Commission  
10 may require, an application containing—

11 (1) a description of the State’s plan under sub-  
12 section (a);

13 (2) a description of the performance measures  
14 and targets the State will use to determine its suc-  
15 cess in carrying out the plan; and

16 (3) such other information and assurances as  
17 the Commission may require.

18 (c) PERIOD OF GRANT; REPORT.—

19 (1) PERIOD OF GRANT.—A State receiving a  
20 grant under this section shall use the funds provided  
21 by the grant over a 2-year period agreed to between  
22 the State and the Commission.

23 (2) REPORT.—Not later than 6 months after  
24 the end of the 2-year period agreed to under para-  
25 graph (1), the State shall submit to the Commission

1 a report on the activities the State carried out with  
2 the funds provided by the grant, and shall include  
3 in the report an analysis of the extent to which the  
4 State met the performance measures and targets in-  
5 cluded in its application under subsection (b)(2).

6 (d) STATE DEFINED.—In this section, the term  
7 “State” means each of the several States and the District  
8 of Columbia.

9 (e) AUTHORIZATION OF APPROPRIATIONS.—There  
10 are authorized to be appropriated for grants under this  
11 section \$25,000,000, to remain available until expended.
